Eoi for Submission of Project Proposals under DDU-GKY

Haryana State Rural Livelihoods Mission (HSRLM) invites proposals under Deen Dayal Upadhyaya-Grameen Kaushalya Yojana (DDU-GKY) from the Project Implementing Agencies (PIAs) having Permanent Registration Number (PRN) obtained from the Ministry of Rural Development (MoRD) placement linked development training under DDU-GKY for approximately **27000** candidates in the state of Haryana. Interested PIAs of different categories may submit their proposal online at www.erp.ddugky.info and are advised to go through the detailed Guidelines & SOP of DDUGKY (available on www.ddugky.gov.in) before applying online. While preparing the proposal, latest CNN (Cost Norm Notification) is to be taken into account. Further, PIAs may keep into consideration below mentioned points before applying:

- (i) Training will be for Residential & Non- Residential courses in the ratio as 80:20.
- (ii) Duration of the course to be undertaken has to be more than 3 months only.
- (iii) Preference will be given to Apparel, Automotive, Aerospace & Aviation, Beauty & Wellness, BFSI, Capital goods, Construction, Chemical & Petro Chemicals, Electronics, Food Processing, Green Jobs, Healthcare, IT-ITeS, Logistics, Retail, Tourism & Hospitality and Power sectors. The PIA will have to pay non-refundable application fee for an amount of Rs 25000/- (Rupees Twenty five thousand only) through NEFT/RTGS to the bank A/C of NIRD&PR given below:

Proposals should be submitted on online portal within **05.00 PM of 25th June 2019**. Applications received after the scheduled date and time shall not be considered. Incomplete proposal shall be summarily rejected. Subsequent to the online submission, soft copy (in PDF format) should be emailed to hsrlmddugky@gmail.com within 2 (Two) days of submission of the online proposal. Hard copy of the proposal should be sent along with a complete set of supporting documents in secured envelope addressed to **The Chief Executive Officer, Haryana State Rural Livelihoods Mission, SCO-19 (1st & IInd Floor), Sector-16, Panchkula, Pincode-134108**. The envelope should be super scribed with 'DDUGKY Project Proposal'. Hard copies of proposals should reach this office within 10(Ten) days of submitting the proposal online but PIAs submitting proposals online on 25th June'19 can submit hard copies of proposal latest by 27th June'2019, 05.00P.M.


Note:



However, the PIAs who have already applied for a smaller target / lesser target in response to Eoi: HSRLM/DDUGKY/2019/752 dated 07.03.19 will have to apply a fresh if they desire higher target.
