### **NIFTY SPOT: IMMEDIATE RESISTANCE AT 11620**



Nifty spot closed 1.15% higher at 11571. Nifty opened gap up and remained strong throughout the session. The sharp up move in index has led index to hit upper trendline of parallel channel and has reversed from the same. Going ahead index has immediate resistance in the range of 11620-11680, this range is expected to act as strong resistance while support comes at 11520-11450.

Bank Nifty spot closed 1.41% higher at 30002.Bank Nifty opened gap up move and remained highly volatile throughout the day. Post sharp up move index has witnessed minor profit booking and has dropped towards its previous gap area which acted an immediate support. Going ahead index has immediate resistance at 30150-30300, this range is expected to act as strong resistance while support comes at 29850-29700.

- ⇒ Nifty Future Open Interest Increased by 5.11%. Bank Nifty Future Open Interest Decreased by 7.64%.
- $\Rightarrow$  Nifty PCR OI Decreased from 1.23 to 1.09, Nifty Bank PCR OI Increased from 0.78 to 0.89.
- ⇒ FII Bought Rs 737.17 crore while DII Bought Rs 339.28 crore in the Cash Segment. FII Bought Rs 1080.09 crore in Index Futures and Bought Rs 3320.57 crore in index options, while in Future they Bought Rs. 264.07 crore and Bought Rs 37.09 in stock options.
- ⇒ Among Index Option space, Highest Open Interest concentration was seen in 11500 & 11200 Strike price among the PE options. Where as among CE Options Highest Open Interest Concentration was seen in 11600 & 11900 Strike price.
- ⇒ Highest Open Interest Build Up among the PE options was seen in 11500 & 11600 Strike price. Among CE options highest build up was seen in 11600 & 11900 Strike price.
