Going ahead till index manages to hold above 12300, index continue to scale higher towards 12420-12500 while support past 12300 comes at 12240-12180 levels.

- ⇒ Nifty Future Open Interest Increased by 1.73%. Bank Nifty Future Open Interest Decreased by 2.67%.
- ⇒ Nifty PCR OI Increased from 1.70 to 1.85, Nifty Bank PCR OI Decreased from 0.95 to 0.94.
- ⇒ FII Sold Rs 205.56 crore while DII Sold Rs 642.47 crore in the Cash Segment. FII Sold Rs 73.15 crore in Index Futures and Bought Rs 1546.5 crore in index options, while in Future they Bought Rs. 321.68 crore and Sold Rs 62.46 in stock options.
- ⇒ Among Index Option space, Highest Open Interest concentration was seen in 12300 & 12000 Strike price among the PE options. Where as among CE Options Highest Open Interest Concentration was seen in 12400 & 12500 Strike price.
- ⇒ Highest Open Interest Build Up among the PE options was seen in 12300 & 12350 Strike price. Among CE options highest build up was seen in 12450 & 12350 Strike price.
