- ⇒ Nifty Future closed with a Premium of 25 points v/s a Premium of 15 points in the previous session.
- ⇒ Nifty Future Open Interest Increased by 1.63%. Bank Nifty Future Open Interest Increased by 1.18%.
- ⇒ Nifty PCR OI Decreased from 1.39 to 1.17, Nifty Bank PCR OI Decreased from 0.87 to 0.83.
- ⇒ FII Bought Rs 264.26 crore while DII Sold Rs 500.17 crore in the Cash Segment. FII Bought Rs 130.15 crore in Index Futures and Bought Rs 489.4 crore in index options, while in Future they Sold Rs.463.76 crore and Bought Rs 29.81 in stock options.
- ⇒ Among Index Option space, Highest Open Interest concentration was seen in 12300 & 12350 Strike price among the PE options. Where as among CE Options Highest Open Interest Concentration was seen in 12400 & 12500 Strike price.
- ⇒ Highest Open Interest Build Up among the PE options was seen in 12350 & 12200 Strike price. Among CE options highest build up was seen in 12400 & 12500 Strike price.
