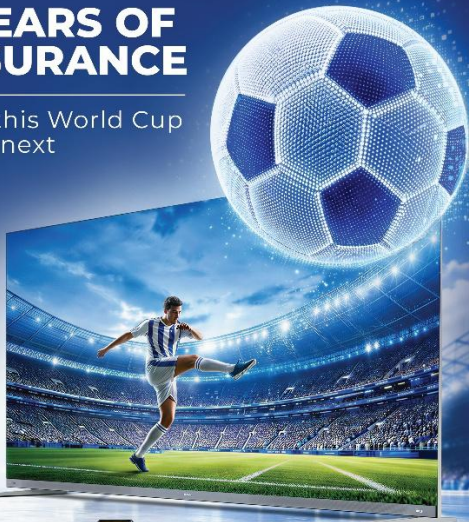

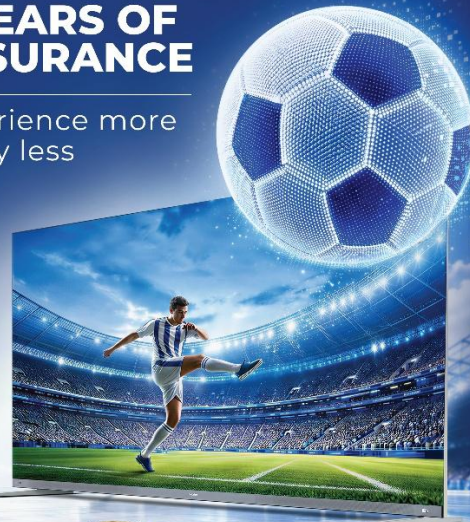

1. This offer is valid for the period **10th June 2026 to 31st July 2026.**
2. 4 Years Warranty: 1 Year standard warranty + 3 Years extended comprehensive warranty*(Series as Mentioned)
3. 3 Years Warranty: 1 Year standard warranty + 2 Years extended comprehensive warranty*(Series as Mentioned)
4. 2 Years Warranty: 1 Year standard warranty + 1 Year extended comprehensive warranty* (Series as Mentioned)
5. 1 Years Warranty:1 Year standard warranty (Series as Mentioned)
6. Extended warranty may differ from model to model, and it is only functional warranty*
7. TV Installation is Free of Cost from Company
8. The TV Shall be repaired or replaced during the warranty period as per the company policy. The Company decision shall be final as per the circumstances. In the event of non-availability of original spares the company may offer, as per company policy, the depreciated value of the product
9. Extended warranty does not cover parts such as aesthetic/Plastic parts, cabinets, stand, accessories such as cables (HDMI, AV, DVI, Remote) & Free gifts. The network (LAN, Internet, Cable signal) related issues in case of smart TVs are not covered
10. For any service under this Extended comprehensive Warranty* Labor Charges will be collected from the customer.
11. For units installed beyond municipal limits of the jurisdiction of company's authorized service centre, it is the responsibility of the purchaser to contact the nearest authorized service centre & bring the unit to the authorized service centre at its own customer cost & risk
12. The customer needs to provide original dealer invoice or register call with Haier customer care for claiming the extended warranty
13. The Company is not liable for any delay in servicing due to reasons beyond the control of the Company or any of its Authorized Service Centres.
14. Parts replaced or repaired under this Warranty are warranted throughout the remaining period of the original Warranty period
15. The Company may repair/supply parts free of cost during the Warranty period. This Warranty does not cover any UTGST / CGST / SGST / IGST and other local taxes or levies on the components/parts.
16. The parts shall be replaced by functionally operating equivalent material only and not necessarily with brand new ones and are likely to be different from the ones originally fitted.
17. The Company reserves the right to retain any part or components replaced at its sole discretion during the Warranty period.
18. Any change of location or change in the ownership during the Warranty period must be intimated in writing to the Company.
19. The Company's employees or its authorized representatives have no authority to vary the terms of this Warranty.
20. This Warranty is effective in New Delhi and claims, if any, shall be made only before the courts having jurisdiction in New Delhi and no claim shall be made against the Company outside New Delhi, notwithstanding that the product may have been sold or delivered elsewhere.
