2. Candidates are requested to collect ADMIT CARDS for GD & PI on **08.07.2026** from MBA (Financial Management) Office in University of Calcutta, College Street Campus in person between **10.00 a.m. – 10.30 a.m.** positively.
3. Candidates are requested to carry their **testimonials** namely **Proof of the Date of Birth, Mark Sheets, Experience Certificates, Caste Certificates (Domicile)** (Where applicable) and **AADHAAR Card** in **ORIGINAL** along with **one photocopy for each testimonial**.
4. Candidates **marked with ***, if selected for admission will have to submit '**Equivalence Certificate**' from University of Calcutta before admission to the course.
5. Candidates must ensure that all the testimonials should carry the same **SPELLING** for their name.
6. Those candidates whose documents are pending/due need to bring photocopies for submission.
