Applications are invited for admission to Ph.D. programme in the Department of Chemical Engineering, University of Calcutta for the year 2024.

Eligibility: Post B.Sc.-B.Tech./B.Tech./BE/ME/M.Tech./M.Phil./M.Sc. Degree

Number of vacancies: 20 (Twenty)

Reservation: Reservation in admission shall strictly be abided by the West Bengal State Higher Educational Institutions (Reservation in Admission) Rules, 2013 and the Memorandum of Government of West Bengal dated 26th May 2023 for Reservation of Economically Weaker Sections (EWSs) in admission in the Higher educational Institution in the State of West Bengal.

It may be noted that the selected candidates, after successful completion of the Programme will be awarded "Ph.D. (Tech.)" Degree in Chemical Engineering.

Requirement of Ph.D. Entrance Test: Candidates having Post B.Sc.-B.Tech./B.E. Degree or M.Sc. Degree are to appear for the Ph.D. Entrance Test for the Ph.D. programme 2024 as per the Calcutta University PhD Regulations, 2016. Candidates appearing in the Final Semester/Year are also eligible.

Qualifying Marks for the Ph.D. Entrance Test will be 50% (as per provision 5.4 of the aforesaid Regulations)

Exemption from Ph.D. Entrance Test (as per provision 5.1 of the aforesaid Regulations): The students who have cleared UGC/CSIR (JRF) Examinations/NET/SET/SLET/GATE or have obtained DST INSPIRE Fellowship /Teacher Fellowship or have passed equivalent examinations or passed the M.Phil./M.Tech./M.E. or equivalent examination shall not be required to appear at the Ph.D. entrance test and they are eligible for directly appearing at the interview.
