Eligibility: Post B.Sc.-B.Tech./B.Tech./BE Degree or Masters Degree in Science.

Number of vacancies: 20 (Twenty)

Reservation: Reservation in admission shall strictly abide by the West Bengal State Higher Educational

Institutions (Reservation in Admission) Rules, 2013.

It may be noted that the selected candidates, after successful completion of the Programme will be awarded "Ph.D. (Tech.)" Degree in Chemical Engineering

Requirement of Ph.D. Entrance Test: Candidates having Post B.Sc.-B.Tech./B.Tech./B.E. Degree (as per provision 6.4 of Ph.D. Regulations of CU, 2016) or Masters Degree in Science (as per provision 5.1 of the aforesaid Regulations) are to appear for the Ph.D. Entrance Test for the Ph.D. programme 2022. Candidates appearing in the Final Semester/Year are also eligible.

Qualifying Marks for the Ph.D. Entrance Test will be 50% (as per provision 5.4 of the aforesaid Regulations)

Exemption from Ph.D. Entrance Test (as per provision 5.1 of the aforesaid Regulations): The students who have cleared UGC/CSIR (JRF) Examinations/NET /SET/SLET/GATE/ Teacher Fellowship or have obtained DST INSPIRE Fellowship / Teacher Fellowship or have passed equivalent examinations or passed the M.Phil./M.Tech./M.D./M.E./M.Pharm. or equivalent examination shall not be required to appear at the Ph.D. entrance test and they are eligible for directly appearing at the interview.
