No.8/50/10 -4HBIV/67 Whereas by notification of the Govt. of Punjab bearing No 8/50/10-4HBIV/2760 dated 2nd November 2010, the State Government in consultation with the Employees's State Insurance Corporation and with the approval of Central Government, gave notice of its intention to extend the provisions of the Employees's State Insurance Act 1948 (34 of 1948) to certain classes of establishments specified in the Schedule to the said notification after one month from the date of that notification;

And whereas the copies of said notification were made available to the public on the 2.11.2010;

And whereas, no objections and suggestions have been received within the said period of one month in respect of said notification;

Now, therefore in exercise of the powers conferred by sub-section(5) of section 1 of the Employees' State Insurance Act,1948 (34 of 1948), the Governor of Punjab, in consultation with the Employees' State Insurance Corporation and with the approval of Central Government, hereby extends the provisions of the said Act to the classes of establishments specified in Column (1) and situated within the areas specified in column (2) of the Schedule in the State of Punjab, namely:-
