No.65..... Whereas by a notification of the Government of Bihar number-832, dated-25.08.10 the State Government, in consultation with the Employees' State Insurance Corporation and with the approval of Central Government, gave notice of its intention to extend the provisions of the Employees' State Insurance Act, 1948 (34 of 1948) to certain classes of establishments specified in the schedule to the said notification after one month from the date of that notification.

And whereas the copies of said notification were made available to the public on Gazette (8th Sept, 2010).

And whereas, no objections and suggestions have been received within the said period of one month in respect of said notification. /And whereas, objections and suggestions received from the persons likely to be affected thereby have been considered by the Government. (Delete whichever is not applicable).

Now, therefore in exercise of the powers conferred by sub-section (5) of section 1 of the Employees' State Insurance Act, 1948 (34 of 1948), the State Government of Bihar, in consultation with the Employees' State Insurance Corporation and with the approval of Central Government, hereby extends the provisions of the said Act to the classes of establishments specified in Column (1) and situated within the areas specified in Column (2) of the Schedule in the State of Bihar namely :-
