Provisional Select list of students for admission to Class IX for the academic session 2025-26 through Lateral entry Selection Test has been released.

The parents/guardians of selected students may take the following steps for admission to Jawahar Navodaya Vidyalaya:

- 1. Formats for submission of details of the candidate may be downloaded.
- 2. Filled in formats are to be submitted to the Principal of JNV concerned in person.
- 3. Certificates from the competent authority in respect of Rural, OBC, SC, ST and Disability as applicable are to be submitted to the JNV for verification of documents / eligibility to confirm admission to Class IX.

If the candidate is found eligible as per NVS norms, after verification of documents submitted by the candidate, JNVs will confirm the admission.

It is informed that admission will be given to the selected candidates, only after due verification of the documents. Parents are advised not to take TC from the previous school until the admission is confirmed by the JNV concerned. Admission to JNVs is done free of cost. No fee is to be paid to school authority for admission to Class-IX. The parents/students are required to approach directly the Principal of the JNV concerned.

The process of admission in JNVs is extremely transparent and activities are visible to all. Accordingly, parents are advised to directly interact with JNV Principal only. In case of any difficulty, an email may be sent to respective Regional Office addressed to the Deputy Commissioner.

DOCUMENTS TO BE SUBMITTED AFTER SELECTION

The parents of the candidates who are provisionally selected for admission will have to submit the following documents at the time of admission for verification: -

- i. Proof for date of birth -The copy of Birth Certificate issued by competent Government Authority concerned.
- ii. Passing Certificate of class VIII from the district concerned.
- iii. For candidates seeking admission under rural quota, the parents will also have to submit a certificate from the competent authority to the effect that the child had studied class VIII in an Institution/ School located in a rural area.
- iv. **Residence Certificate**: The valid residential proof (as notified Govt. of India) of the parent of the same District where the JNV is located & candidate has studied class VIII shall be furnished.
- v. Aadhar Card of the candidate: As per section 7 of Aadhaar act, 2016, the provisionally selected candidate has to submit the copy of Aadhaar Card to get the benefits such as boarding & lodging, assistance for stationeries and other benefits under the Navodaya Vidyalaya Scheme.
- vi. Certificate by the Head Master of the school regarding study details.
- vii. Medical fitness certificate.
- viii. Undertaking by the parent/guardian to pay Navodaya Vikas Nidhi every month as per norms of NVS.
- ix. Disability certificate (if applicable)
- x. Category/community certificate (SC/ST) if applicable.
- xi. Category/community certificate OBC, **as per central list** if applicable. (Format Attached)

Note: - The TC from parent school after the verification of documents and confirmation of admission by the respective JNV is to be submitted after getting counter signature of District Education Authorities (DEO/BEO etc.)
