Subject: Intimation of closure of Trading Window in terms of Company's "Code of Conduct to Regulate, Monitor and Report Trading by Designated Persons and their Immediate Relatives" ("Code")

Dear Sir(s)/Madam(s),

This is to inform that in terms of the Code adopted under the SEBI (Prohibition of Insider Trading) Regulations, 2015 and the clarification provided vide NSE Circular Ref No. NSE/CML/2019/11 dated April 2, 2019 and BSE Circular Ref. No. LIST/COMP/01/2019-20 dated April 2, 2019 regarding trading restriction period, the Trading Window for dealing in the equity shares of the Company shall remain closed, from Wednesday, October 01, 2025 till completion of 48 hours after the declaration of Unaudited Financial Results (Standalone and Consolidated) ('UFRs') of the Company for the quarter and half year ending on September 30, 2025 with the Stock Exchanges.

Accordingly, the Designated Persons ('DPs') and their immediate relatives are prohibited to enter into any transaction involving dealing/ trading in the equity shares of the Company during the aforesaid period of closure of trading window.

Additionally, freezing of PAN of DPs and their immediate relatives at designated Depository portal i.e. National Securities Depository Limited portal shall be facilitated in accordance with the applicable SEBI Circulars dated August 5, 2022, July 19, 2023 and April 21, 2025 read with NSE and BSE FAQs.

The date of Board Meeting for the consideration and approval of the UFRs for the quarter and half year ending on September 30, 2025 shall be intimated in due course.
