3. **AIMS AND OBJECTS** :

RULES AND REGULATIONS

1. Name of the Association : **NARAYANA EDUCATIONAL SOCIETY**
2. Address of the Office : **14/72, Haranadhapuram, Nellore - 524003 (A.P)**

3. **MEMBERSHIP:**

Any person who has completed the age of 18 is eligible to become a member of the Society, provided that he / she agrees to abide by the Rules and Regulations of the Society and shall prefer to pay an entrance fee and subscription which may subsequently be enhanced from time to time. On the approval of admission by the Managing Committee the member shall pay an amount of Rs.5/- towards entrance fee and yearly subscription of Rs.50/-. All the members shall pay yearly subscription before 10th August every year, failing which such member shall lose voting power. If such persons want to be enrolled again as fresh members they can do so with the approval of the Managing Committee.

4. **MANAGING COMMITTEE:**

The Managing Committee shall be elected by the members of the Society in the General Body Meeting. The Managing Committee consists of 7 members including office bearers as follows:

i)	President	:	1
ii)	Vice President	:	1
iii)	Secretary	:	1
iv)	Joint Secretary	:	1
v)	Treasurer	:	1
vi)	Executive Members	:	2
Total...			7

5. **DUTIES OF OFFICE BEARERS:**

- a) **PRESIDENT:** The President shall be the Head of the committee, control and organise the establishment in discipline, and give in time of emergency, rulings for the sake of the orders, preside over all meetings and do justice. He / She will keep all Office records, furniture and documents relating to the Society.
- b) **VICE PRESIDENT:** The Vice President shall in all aspects co-operate with the President in connection with the functioning of the Society and preside over all meetings in the absence of the President.
- c) **SECRETARY:** The Secretary will attend to office work and correspondence. He / She will convene and conduct meetings by issuing notices to all members in time, prepare agenda for all meetings for approval and he / she can arrange special meetings and audit of the accounts.

- c) JOINT SECRETARY: The Joint Secretary shall in all respects co-operate with the Secretary in connection with the working of the Society and take charge in the absence of the Secretary.
- d) TREASURER: The Treasurer will maintain cash, accounts, funds of the Society, collect contributions, donations and grants and shall issue proper receipts. He / She shall keep the money in bank which is authorised by the Managing Committee.
6. **MEETINGS:**
- a) GENERAL BODY MEETING:
- The General Body shall meet once in a year i.e., in the month of August every year. 15 days notice shall be given to all members for convening General Body meeting.
- b) MANAGING COMMITTEE MEETING:
- The Managing Committee shall meet once in three months to review the working of the Society, discuss various subjects that are placed before it and pass necessary resolutions. 7 days notice shall be given to all members of the Managing Committee.
7. **POWERS OF GENERAL BODY AND ITS FUNCTIONS:**
- i) To elect the Managing Committee Members.
- ii) To pass the Budget for the ensuing year and to approve the expenditure statement of the previous year.
- iii) To approve the activities of the Society.
- iv) To appoint an Auditor or Tax Practitioner to audit the accounts of the Society, if necessary.
- v) To amend or alter the rules and regulations of the Society.
8. **QUORUM:** The Quorum for the General Body and Managing Committee meetings shall be 2/3rd majority of members on rolls present.

9. **FUNDS:** (as amended - 11.11.2000) The funds of the Society consist of subscriptions and contributions made by the members of the Society, donations received from public and grants from Government etc. The funds collected or received shall be deposited in the name of the Society in any Scheduled Bank or a Co-operative Society engaged in carrying on the business of banking or any other bank being a bank included in the second Schedule to the Reserve Bank of India Act, 1934 (2 of 1934) after obtaining the approval of Managing Committee. Any withdrawal of money shall be made with the signature of either President or Vice-President or Treasurer. In no way the funds of the Society shall be mismanaged or misused.

The Society can borrow funds from banks, institutions, firms, companies and individuals as may be necessary for the development of the Society. The President or Vice-President or Secretary is authorised to borrow funds.

The Society shall solely utilise its income or funds for furtherance of its objects and shall not distribute any part of it amongst the members of the Society by way of profit or dividend or otherwise.

10. (as added - 11.11.2000) The Society shall not change its name once it is registered under any circumstances.
11. (as added - 11.11.2000) The Society shall maintain its accounts regularly and get the accounts audited by a Chartered Accountant every year.
12. (as added - 11.11.2000) The Society shall not carry out any activity anywhere outside India.
13. **AMENDMENTS:** (as amended 27.10.1999) Any amendment or alteration of any rule or of making any rule shall be made in accordance with the procedure laid down in the Act in the interest of the Society, in good faith. The General Body shall have the power and authority of making amendments or alterations or of any kind of inclusion in the rules and regulations. No amendment shall be made unless it is admitted and then discussed by the members of the General Body and then voted by 3/5th majority of members present at the meeting and later on again after 30 days voted and confirmed by the same 3/5th majority of the members so present at a second special General Body meeting convened for the purpose. Any such amendment to the objects shall be with the approval of the Commissioner of Income Tax.
14. **WINDING :** (as amended 27.10.1999) In case the said Society has to be wound up under any circumstances the matter may be admitted and discussed in the General Body meeting and if it is found necessary for doing so, the matter shall be placed for voting. When the matter is voted and come out with 3/5th majority of members present, steps shall be taken to windup the Society.
- In winding up of the Society the properties and funds relating to it that remain after the full satisfaction of all the liabilities of the Society shall be transferred or paid or delivered to some other Society having similar aims and objects and which is registered under Section 12(A) of the Income Tax Act and recognised under Section 80(G) of the IT Act.
15. The Society shall have the power to modify, amend or cancel any of these rules and regulations, subject to the provisions of the Societies Registration Act XXI of 1860.
