The MEO Ibrahimpatnam Mandal Ranga Reddy District has caused inspection in this regard and submitted his report in the reference 4th cited.

After careful examination of the proposals and recommendation of the Mandal Education Officer Ibrahimpatnam (M) R.R.District and in terms of the orders issued in the references 1st to 3rd cited, the District Educational Officer, Ranga Reddy District us hereby accorded Opening Permission to classes I to V (EM) during the year 2022-23 in Narayana EM School, Kongarakalan, Ibrahimpatnam Mandal, Ranga Reddy District with instructed to follow the under mentioned instructions scrupulously.

- 01. That the society shall abide by the instructions/rules and regulations made by the Government or authorized officer time to time.
- 02. That the society shall provided the necessary amenities like accommodation, sanitary facilities, drinking water facilities, library, laboratory equipments, play filed, required staff as per the pattern and other facilities are necessary before approaching the competent authority.
- That the society shall apply for recognition by within (60) days at the latest duly fulfilling the conditions.
- 04. That the permission accorded is restricted to the same year only.
- 05. That this permission does not confer any right on the society for claiming reorganization.
- 06. That the permission to accorded to open to Narayana Educational Society and no other society or body can open a school their behalf.
- 07. The Permission is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
- 08. The society shall provide the necessary material even it is cost more that the deposit amount. .
- 09. That all the conditions prescribed in the GO's and other orders which are not specified in the order shall be complied with.
- 10. Proper sanitation facility shall be provided for students especially for girl students.
- Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
- 12. The School follow the traffic and safety guidelines indicated by the police and fire services of department.
- 13. The parent teacher association meeting shall be conducted to sensitize the parents on the safety of the children.
- 14. The school shall have first aid kit and the teachers shall be treated in first aid..
- 15. The above permission is accorded purely on a temporary basis and is subjected to the reports of the State Level Inspection and Vigilance Committee fulfilling of all the perquisite condition under the A.P Education Act 1982 and if later found that the school has not fulfilled any perquisites as stipulated, the permission now being given is liable to be withdrawn at once.
- 16. That the Educational Society shall follow the Examination Schedule as per the time table issued by the DCEB and should conduct DCEB Question papers for Quarterly, Half-yearly, Annual and Pre-final examinations.
- 17. The Society shall provide, the necessary material even if it is costs more than the deposit.
- 18. That the Educational society shall not conduct any events for children which will harm to lives.
- 19. That the Educational Society shall not conduct classes on public holidays/ summer holidays /short term holidays without permission from the undersigned.
- 20. That the Educational Society should constitute parents teachers committee and should conduct meeting with a committee once in a month.
- 21. That the Educational Society should not open counters for selling books/ badges/stationary etc.

- 22. That the Educational Society shall follow school timings as prescribed by Government in school academic calendar.
- That the Educational Society should follow school timings as prescribed by Government in school academic calendar.
- 24. That the Educational Society shall not conduct any events for children which will harm to lives.
- 25. That the Educational Society shall not conduct classes on public holidays/summer holidays/short term holidays without permission from the undersigned.
- 26. That the Educational Society should constitute parents teachers committee and should conduct meetings with a committee once in a month.
- That the Educational Society should not open counters for selling books/badges/stationery etc.
- That the society/school shall abide by the provisional of Right of Children to Free and Compulsory Education Act, 2009 and the rules thereof.
- 29. That the school management shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker sections and disadvantaged groups in the neighborhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre-primary classes also, its norms shall be followed.
- 30. That the society/school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screen procedure.
- 31. That the school management shall not deny admission to any child
 - e) For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - f) On the ground of religion, caste or race, place of birth or any of them.
- 32. That the management of school shall ensure.
- 33. No child admitted be held back in any class or expelled from school till the completion of elementary education in a school.
- i) Child shall be subjected to physical punishment or mental harassment.
- No child is required to pass any board examination till the completion of elementary education.
- iii) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.
- iv) Inclusion of students with disabilities/special needs as per provisions of the Act.
- v) The teachers are recruited with minimum qualifications as laid under section 23 (1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications with in a period of 5 years.
- vi) The teacher performs his/her duties specified under section 24 (1) of the Act and
- vii) The teacher shall not engage himself in private teaching activities.
- viii) That the management of school shall enroll students proportionate to the facilities available in the school as prescribed in section 19 of the Act.
- 34. That the management of school shall maintain the standards and norms of the school as specified in section 19 of the Act.
- 35. No un-recognized class shall run within the premises of the school or outside in the same name of school.
- 36. That the school buildings or other structures or the grounds are not used during the day or night for commercial or residential purposes (except for the purpose of residence of any employee of the school) opr for political or non-educational activity of any kind whatsoever.
- 37. That the school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
- 38. That the school is not run for profit to any individual, group or association of individuals or any other persons.
- 39. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements of Accounts should be sent to the District Educational Officer every year.
- 40. The recognition Code Number allotted to your school is 184/A1/2022. This may please be quoted for any correspondence with this office in future.
- 41. The school furnishes such reports and information as may be required by the Rajiv Vidya Mission/District Educational Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working if the school.
- 42. The recognition shall be withdrawn if the contravention of the provisions of the Act. The Rules and conditions of recognition is found and proved.

- 4. That the Renewal Recognition is accorded to the Narayana Educational Society.
- 5. The Renewal Recognition is accorded to run the school in the locality and there shall not be any change in the premises of locality specified in the orders.
- 6. The management should follow the G.O.Ms.No.22 ,dated 18-07-2017 i,e ., the weight of the school bag not to exceed 4kg for VI-VII,4.5 kg for VIII-IX and 5 kg for X.
- 7. That the administrative report and the audited statement of accounts of the school duly attested by the Chartered accountant for every financial year shall be submitted to the District Educational Officer, latest by September
- 8. The Management has to follow the government norms from time to time, for collection of fee from students.
- 9. That educational agency shall not use the premises building, play ground and vacant site belongs to the institution for any purpose other than the Educational activities and conducting authorized examinations without permission of DEO.
 - 10. The management should follow the guidelines issued in G.O.Ms. No. 36., School Education (General) Dept., Dt:- 16-12-2017 for the safety and security of the children in the schools.
- 11. The management should pay the mandate taxes due to the concerned departments as per schedule fixed by the Government.
- 12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments
- 13. The school shall have 'first aid-kit' and the teachers shall be trained in first aid.
- 14. That any children studied in recognized school of other states/countries affiliated to the bodies recognized by the state or central government shall not be admitted without prior permission of the District Educational Officer/Director of School Education.
- 15. That the management shall not collect any fees or donations either in cash or kind other than the fees prescribed by the governing body from pupils or parents or any other person or on their behalf for any purpose.
- 16. That educational agency shall not force any member of the staff or students of the institutions to take part in the religious discourses and preaching of religion irrespective of whether they belong to the same belief or not.
- 17. If the Management provides transportation, it is the responsibility of the Management to submit Fitness Certificates of their buses every year regularly to the D.E.O. to have skilled, Trained, Licensed and healthy driver. If any deviation in this matter, they will be personally held responsible.
- 18. The Correspondent should submit Renewal of Recognition proposals before 90 days of the expiry of Renewal Recognition.

- 20. The Educational Agency should Implement the Model Education Code prepared by National University for Educational Planning and Administration in 2015
- 21. That educational agency shall not permit the students of any D.Ed/B.Ed colleges or college of physical education or any teacher training institution to have teaching practice without the permission of the District Educational Officer.
- 22. Proper and adequate parking area for vehicles shall be provided transporting the children to and from the school.
- 23. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
- 24. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children
- 25. The school shall constitute Committees for reddressal of the Public/ Staff/ Parents/ Students grievances, Internal Complaints Committee on Sexual Harassment and Committees under POCSO (Protection of Children from Sexual Offence) Act, 2012 and details of these Committees along with contact details shall be displayed prominently on School Notice Board and conspicuously on the School Website for the information of all the stakeholders.
