AFFIDAVIT

I, V. Srinath Son of Late Sh. V. Sridhar, age 45 years, Joint Secretary of the Narayana Educational Society running the Narayana e-Techno School, Dora Road, Bareilly do hereby solemnly affirm and sincerely state as follows:

- 1. That Narayana Educational Society is a registered Society under the Registration of Society Act XXI of 1860.
- 2. That the Narayana Educational Society is of Non-Proprietary Character.
- 3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
- 4. That no part of income from the Institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.

That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE TA pame in any manner without obtaining affiliation.

7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time.

Yatle school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.

Bares, like the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with Rag. No. 18 Spect to the school and staff of the school.

- 16. That the school will not start CBSE pattern classes without submitting a commencement certificate to the effect that the school has complied with all the conditions imposed by CBSE and the post-affiliation conditions contained in affiliation byelaws along with general rules.
