Financial Overview

The cost of full-time tuition for the MSAECM program in the 2024-2025 Academic Year (Fall & Spring semesters) will be \$41,000. With the Merit Scholarship, your net tuition for 2024-2025 will be \$35,000. Tuition rates for the 2025-2026 Academic Year are subject to change and will not be determined until March 2025. Please expect that they will be equal to or greater than the per-semester cost of the 2024-2025 Academic Year rate.


Additional support can be obtained through paid Graduate Teaching and Research Assistantships, to which all graduate students may apply. These are usually arranged once the student arrives on campus and are up to \$1,000 per semester. Program Details

The Master of Science in Architecture-Engineering-Construction Management (MSAECM) program is jointly offered by the School of Architecture and the Department of Civil & Environmental Engineering (CEE) at Carnegie Mellon University. The MSAECM degree program focuses on the integration of design and technology, particularly advanced information systems, as a means of both improving building performance and enhancing environmental sustainability. Students will work with the track chair to create a program of study that reflects each student's background and career goals by taking a mixture of appropriate prerequisites; core courses; "selectives" in Sustainability Assessment, Management, Computational Skills, and Quantitative Modeling; and approved electives. Carnegie Mellon University's MSAECM program is designated as a STEM-eligible program.

The 16-month MSAECM program requires a minimum of 120 units of approved coursework (including a required summer internship) with a minimum residency of three (3) academic semesters at full-time status (minimum of 36 units per semester).

MSAECM students will have the opportunity to learn from a diverse and innovative group of faculty within the School of Architecture. Your faculty track chair advisor will be Joshua D. Lee (jdlee2@andrew.cmu.edu). Do not hesitate to contact your track chair by email if you have questions



regarding academic aspects of the program. Additionally, our Director of Recruitment & Enrollment, Alexis McCune Secosky (amccune@andrew.cmu.edu) will gladly address administrative questions about the program, the School of Architecture, and Carnegie Mellon University.

All incoming Master of Science in Architecture-Engineering-Construction Management students **are not required but have the option** to complete a free online course, Digital Skills Workshops (DSW), to establish a baseline of digital design skills expected at the Graduate Program. This fully remote course will run this summer prior to the academic semester with an anticipated time commitment of 5 hours/week. You are encouraged to consult directly with your track chair advisor to determine if the DSW will be helpful for your individual course of study. Applicants who accept this admission offer will receive more details about DSW with incoming Carnegie Mellon Architecture Graduate Program student enrollment information to be sent in May.






