



# INFRASTRUCTURE AND RESOURCES




This fully-residential campus is a blend of traditional Odia Architecture with modern amenities and resources.

## CCR Conduit

The school provides quality teaching in the field of Law and interdisciplinary studies, internship and placement opportunities, advocacy, legal aids and promotion of independent research in specific area of interest Birla Global University has entered into multiple MOUs and collaborations to facilitate internships and research opportunities for BSOL (Birla School of Law) students and graduate. This includes tie-ups with Universities, Law-firms and civil societies, activities helpful for placement. Intake capacity for 5 years integrated BBA.,LL.B.( Hons.)-60. The minimum qualification prescribed for the students seeking admission is +2 pass in Arts/ Science/ Commerce securing 45% marks minimum.

## Eligibility Criteria



- 1. Minimum marks in qualifying examination for admission :** The Bar Council of India may from time to time, stipulate the minimum percentage of marks not below 45% of the total marks in case of general category applicants, 42% for OBC category and 40% of the total marks in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 examination in case of Integrated Five Years' course or Degree course in any discipline for Three Years' LLB course, for the purpose of applying for and being admitted into a Law Degree Programme of any recognized University in either of the streams.
2. Provided that these minimum qualifying marks shall not automatically entitle a person to be admitted into an institution but shall only entitle the person concerned to fulfil other institutional criteria notified by the institution concerned or by the government concerned from time to time to apply for admission.

**\* For admission into BBA.,LL.B. (Hons.) programme of BGU Bhubaneswar the applicant must have a valid CLAT/LSAT/AILET/XLET/BGU Admission Test score.**

# About **LL.M.**

The Course offered by the Birla Global University Bhubaneswar, is the **One Year LL.M. Degree**, which is in conformity with the UGC Guidelines for introduction of One Year **LL.M. Degree Programme, 2012**. (Notification dated 18.1.2013).

## **Eligibility:**

Admission to the LL.M. Degree Course of study shall be open to those candidates who have passed the Three-Year LL.B. Degree Examination from a

recognized University or Institution after Graduation under 10+2+3+3 pattern; or Five Year LL.B. Degree Course under 10+2+5 pattern as is recognized by this University as equivalent for the purpose of LL.M. Degree Course and have secured not less than 50% marks in aggregate for the general applicants, and not less than 45% marks in aggregate for the SC and ST applicants, in the LL.B. Examinations.

The University shall conduct LL.M Entrance Test (LET) for each academic session. Admission shall be made according to merit in the LET subject to the fulfilment of eligibility requirement as determined by the University and availability of seats in LL.M. Course. The students who have passed the CLAT or LSAT examinations shall also be allowed to join the course subject to availability of seats.



## Course Structure:

Students admitted to the One Year LL.M. Degree program at School of Law, Birla Global University have to complete three mandatory papers, six optional papers and a dissertation in order to complete the program.

The following specializations are offered by the University: 1) Corporate and Commercial; and 2) Criminal Laws. The University may expand the number of specializations if merited by the faculty expertise.

Students admitted to this program are required to study and complete the following mandatory courses.


