BRIEF BIOSKETCH

Prof. Geer Mohammad Ishaq has been serving as a faculty in Pharmacology at the Department of Pharmaceutical Sciences, University of Kashmir over the last twenty-three years. At present he is also holding the additional charge of Director, Directorate of Lifelong Learning, University of Kashmir. Prior to joining University of Kashmir, Prof. Geer has served as a Drug Control Officer at Drug and Food Control Organization (DFCO), J&K for a period of around three years. Prof. Geer has completed his post-graduation in Pharmacology from Rajiv Gandhi University of Health Sciences (RGUHS), Karnataka with Distinction and his doctorate in the same subject from University of Kashmir. He has been instrumental in designing and starting a post-graduate programme in Pharmacy Practice in the year 2009 and is at present in-charge of this PG programme offered by the University of Kashmir. Prof. Geer has earlier served as Director, Centre for Career Planning and Counselling, University of Kashmir for a period of around three years from 2021-2024 and as Coordinator of UGC-Human Resource Development Centre (HRDC) of the University of Kashmir for a period of around five years from 2016-2021. In these capacities he has organized and conducted numerous coaching programmes for civil service and NEET aspirants, career counselling sessions for college and university students, campus recruitment drives for college and university students, faculty development programmes including orientation and refresher courses for college and university teachers. Prof. Geer has published 51 research papers and presented 48 papers in various national and international conferences. He and his research team has won six best paper awards in various conferences and journals. He has delivered 170 extension lectures on diverse topics outside his department besides publishing 125 popular articles in print media. He is a peer reviewer and editorial board member of several highly reputed national and international journals and has reviewed more than 60 papers for the same. Prof. Geer has also been appointed as Member Expert Committee on Antibiotic Utilization under National Drug Utilization Evaluation Programme of India, by the Indian Council of Medical Research (ICMR), New Delhi. 15) Important Scientific Achievements:

In light of the unprecedented threat posed by genotoxic agents like mutagens and clastogens existing in the environment, present in human diet and those produced endogenously in humans that have been causing deleterious heritable changes without showing any immediate toxic effects, applicant has in three separate studies established the anticlastogenic effects of essential oil of *Cymbopogon citratus* and extracts of *Ocimum sanctum* and *Rosmarinus officinalis* in-vivo in Swiss albino-mice using mouse bone-marrow

Micronucleus Test and Chromosome Aberration Test as parameters for anticlastogenic activity. Besides, applicant has for the first time studied and reported the hypotensive effect of aqueous extract of *Emblca officinalis* on mean arterial blood pressure of experimental dogs.

Completed work on the doctoral research project entitled, “Prospective adverse drug reaction monitoring studies in Kashmiri patients” which is the first of its kind in the entire state of J&K since no such initiatives have so far been taken by any section of the medical or para-medical fraternity within the state. Therefore, such type of research in the state assumes pioneering and path-breaking significance. During the project Adverse drug reaction monitoring was undertaken on 5482 patients of Kashmiri origin presenting to IPD, OPD and emergency departments of SKIMS, Srinagar.
