4. Service rendered up to **16-04-2025** shall be considered for considering candidates under In-service Quota seats.
5. Service candidates should not have completed 50 years as on **16-04-2025**. Candidates born on or before **16-04-1975** are not eligible for In-service quota seats only.
6. As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 of Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats in Medical/Dental colleges are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.
7. As per G.O.Ms.No.83, dt. 23-07-2025 of HM & FW (C1) Dept., Govt. of A.P the admission to 85% of the seats in each course in non-state wide institutions shall be reserved for the local candidates of Andhra Pradesh and the remaining 15% of the seats shall be un-reserved seats for the candidates of local/non local areas.

**8. Filling up of PG (Medical) Seats in Siddhartha Medical College, Vijayawada for the academic year 2025-26:**

The Government of Andhra Pradesh vide G.O.Rt.No.475, HM&FW (C1) Dept., dt.22-07-2025 ordered "to continue Siddhartha Medical College, Vijayawada as a State wide Educational Institution and admissions to 85% of the available seats (after deducting All India Quota seats) shall be divided between local candidates of Andhra University and Sri Venkateswara University regions in the ratio of 65.62% and 34.38%, with the remaining 15% treated as unreserved.

The definition of local candidates and eligibility in respect of 85% local seats and 15% unreserved seats shall be as per respective admission rules of Undergraduate Medical and Postgraduate Medical courses applicable to Government Professional Institutions."

9. As per Memo No.2832690/C1/2025, dt.15-07-2025 of HM&FW (C1) Dept., Govt. of AP the Caste certificates issued by the Government of A.P will only be considered for admissions.
  - Latest Permanent caste certificate (issued by Competent Authority of Govt. of Andhra Pradesh only). Caste certificates of other States will not be accepted & in such cases the applied candidate will be considered under General category only.

**3. As per G.O.Ms.No.102, HM&FW (C1) Dept., dated 15-07-2023 in Non-minority Medical Colleges:**

Sub Category-1-S1 (S1A & S1B):-

- i. 15% of Subcategory-1 (S1A) seats only are open to the candidates from all over the Country.
- ii. For the Remaining 85% of Subcategory-1 (S1B) seats only Local Candidates of Andhra Pradesh i.e., AU/SVU are only eligible.

**4. Local Area:**

- i. The entire state of Andhra Pradesh shall be treated as two local areas for the purpose of admissions into Post Graduate Courses in Medical Colleges” i.e., Andhra University and Sri Venkateswara University (including SVIMS) areas for filling up the 85% of Sub category-1 (S-1) seats in private un-aided Non-minority Medical Colleges in the State of Andhra Pradesh.
- ii. **For the candidates who have completed** MBBS from Govt. Siddhartha Medical College, Vijayawada the Local area of the candidate shall be decided by considering the maximum study period of 4 years out of 7 years of study from 6<sup>th</sup> class to Intermediate/10+2 in the State of Andhra Pradesh.
- iii. For Category–C–NRI(S2): Shall be filled with NRI / NRI Sponsored candidates on the basis of Merit among the applicants qualified in NEET PG-2025.
- iv. For Category–C–Institutional Quota(S3): Shall be filled with the candidates qualified in NEET-PG -2025 sponsored by the Managements of the Private Colleges having Post Graduate Courses in the State of Andhra Pradesh.

**5. As per G.O.Ms.No.74, HM&FW (C1) Dept., dated 06-06-2023 in Minority Medical Colleges:**

- i. Management Quota-Subcategory-1(S1): 25% of the sanctioned intake of seats, course wise, in each institution shall be filled by the candidates in General Merit based on the NEET PG-2025 ranking.
  - ii. Management Quota-Subcategory-2(S2): 15% seats out of total intake capacity, course wise, in each institution shall be filled by foreign students/ NRI/NRI sponsored candidates on the basis of inter-se-merit among the applicants qualified in NEET PG-2025.
  - iii. Management Quota-Subcategory-3(S3): 10% seats out of total intake capacity, course wise, in each institution shall be Institutional preference/In-service management quota seats filled on the basis of inter-se-merit among the applicants qualified in NEET PG-2025.
