**Eligibility and Instructions for Counselling:**

- Candidates who submitted applications under the Farmers' Quota within the stipulated time but were not allotted a seat are eligible to attend the counselling.
- Candidates who did not submit applications earlier may also attend the counselling as walk-in applicants with a duly filled-in application, the required certificates, and the registration fee in the form of a Demand Draft.

**Admission Procedure:**

- Admissions will be made **strictly on the basis of merit ranks in AP EAPCET (Engineering Stream) and Rule of reservation.**
- In case of non-availability of candidates in any category, the seats shall be **converted as per the Rule of Reservation** and allotted to eligible candidates.

### **Eligibility:**

#### **B.Tech. (Dairy Technology) under MPC Stream**

A pass in two-year Intermediate Examination conducted by the Board of Intermediate Education, A.P. or any other examination recognized as equivalent thereto by the University or Intermediate Board with Mathematics, Physics, Chemistry and English subjects.

#### **Criteria for selection:**

The selection of candidates for all the seats shall be made based on ranks obtained by the candidates in the AP EAPCET 2025. The candidates will be selected based on merit, presidential order, region and social status. In case of a tie in ranks obtained by two or more candidates in the AP EAPCET 2025, the marks secured in the optional subjects of the qualifying examination shall be taken into consideration. In case of a further tie, the upper age of the candidate shall be taken into consideration.

#### **Age:**

The candidates for admission to these courses shall be required to have completed 17 years of age on 31<sup>st</sup> December, 2025 with an upper age limit of 22 years for all the candidates, 25 years in respect of SC and ST candidates and 27 years for Physically Handicapped (Differentially abled) candidates.

**Reservations:**

**Reservation of seats for the candidates coming from families of Agriculturist cum Rural Area (Farmers' Quota):**

- **The seats** are reserved for candidates coming from families of Agriculturists (Farmers) owning **not less than 1 acre of land either in the name of the parent/(s) or in the name of the candidate** and who have studied for a **minimum of 4 years in schools located in Non-Municipal areas (from 1<sup>st</sup> class to Intermediate/10+2)**. Land owned by **grandfather, grandmother, guardian or any other relative is not acceptable**.
- **FORM-I:** It is a proforma indicating the patta numbers and extent of land owned by the **candidate / parents** duly certified by **the Mandal Revenue Officer / Tahsildar with office seal recently (or)** the candidate has to enclose attested xerox copies of **pattadar passbook** as evidence of the possession of land.
- **Form-II:** It is a proforma to be certified by **the Head** of the School / Institution with office seal recently that the candidate has studied for a **minimum period of four years in schools located in Non-Municipal areas** during their period of study from 1<sup>st</sup> class to 12<sup>th</sup> class / Intermediate (**Non-Municipal Area Study Certificate**).
- **Form-I and Form-II** need to be filled in with the **signatures of concerned officials viz., Mandal Revenue Officer / Tahsildar and concerned Head of Institution, respectively**, along with office seal. Otherwise, the claim of the candidates under this category will be summarily rejected.

**Allotment of seats during counselling process:**

The allotment of seats will be done during **counselling**. The dates and venue for the counselling will be notified later on the university website [svvu.edu.in](http://svvu.edu.in). The candidates who submit application form with all enclosures including the demand draft will be called for counseling for allotment of seats based on merit in AP EAPCET, 2025 and rule of reservations from time to time.
