

He obtained his B.A. and M.A. in history from Jain College, Jabalpur. He took his Bachelor's degree in Divinity (B.D.) from General Episcopal Seminary, New York and Master's degree in Sacred Theology (S.T.M) from Konnett Berkeley Divinity School, Yale. In 1990 he was awarded Doctor of Divinity by General Theological Seminary, New York. The mission of His Grace remains the guiding star of the College.





ADMISSION PROCEDURE

GUIDELINES

All admissions at St. Thomas College are carried out on the basis of merit and in a transparent manner. The admission in graduate and post graduate courses are followed as per the guidelines specified by the Higher Education, Raipur, Chhattisgarh and Hemchand Yadav Vishwavidhyalaya, Durg CG.

Those desirous of seeking admission to any of the courses will have to fill in online/offline application form supplied from college office from 16.6.2024 onwards. Application forms received after 16.8.2024 may also be considered for admission subject to the availability of seats. Candidates applying for PG courses should submit the application form within 10 days after the declaration of results of the qualifying exam.

THE FOLLOWING DOCUMENTS ARE TO BE SUBMITTED ALONG WITH THE APPLICATION:

- Photo copies of mark sheet of X , XII and Graduation (for PG Courses)
- Photo copy of document to prove SC/ST/OBC Status.

List of candidates selected for admission will be published on college website/notice board

DOCUMENTS TO BE PROVIDED AT THE TIME OF ADMISSION

- Photo copies of mark sheet of X , XII and Graduation (for PG Courses).
- Original Transfer Certificate/ Character Certificate.
- Original Migration Certificate of students from other Universities and CBSE/Other State Boards.
- Original Gap Certificate should be submitted by candidates having discontinuity in studies.
- Candidates on job should produce No Objection Certificate from their respective office.
- Candidates belonging to SC/ST/OBC should produce Caste Certificate.
- Income Certificate of the parent/guardian from their respective office.
- One latest passport size photographs.
- **AFFIDAVIT:** It is mandatory as per the Hon. Supreme Court & UGC / AICTE Regulations that all students fill in the Anti Ragging Affidavit each year. To make the process easy, MHRD has developed an ONLINE facility. Affidavit can be obtained from any of the two Websites: ***www.antiragging.in or www.amanmovement.org. Please go through the above mentioned websites and fill the form, Submit printout of the duly signed form along with the application.***
- Eligibility Certificate (Original & photocopy). This is applicable only for those students who have passed their qualifying examination from any Board/university other than C.G. Board / CBSE / Hemchand Yadav Vishwavidyalaya, Durg CG.

Note: All original certificates are to be produced during counseling.

OFFICE PROCEDURE

ISSUE OF TRANSFER AND CHARACTER CERTIFICATE

Application form for the issue of Transfer and Character Certificate can be obtained from the college office. The request will be processed only from the date of receipt of the following

- 1. Photocopy of Marksheet received from the college
- 2. Library clearance
- 3. Duly filled feedback form of the college

TC and CC will be issued by the institute on paying fees of Rs.15/- on receipt of application and processing fees, TC will be issued in three working days. For duplicate TC, students will have to pay a fee of Rs 250/-.

MIGRATION CERTIFICATE

- Request for migration certificate must be made in an application.
- In case of cancellation of admission before the form is submitted to the University for Enrolment then the College will give back the original migration certificate. Otherwise the certificate will be issued from the Hemchand Yadav Vishwavidhyalaya, Durg, C.G
- After course completion the Hemchand Yadav Vishwavidhyalaya, Durg, C.G will issue the certificate. Charges apply.



REFUND OF CAUTION MONEY

- Request for Refund of Caution Money must be made in an application. The request will be processed only from the date of receipt of the following documents
- 1. Copy of ID Proof (Aadhar Card/Voter ID/Pan Card)
- 2. Copy of Transfer Certificate
- 3. Copy of Mark sheet
- If fee and other charges are not paid in time the same shall be deducted from the caution money and only the balance money will be refunded in full and final settlement of the claim for refund.

STUDENT'S CONDUCT AND BEHAVIOUR

- Character building is the main aim of education and the College lays great emphasis on good character and decent behaviour from every student.
- The student must be decently dressed to suit the academic environment of the College. Those who intentionally violate this rule shall not be permitted to attend the classes and will have to leave the campus.
- The behaviour of the students, both within and outside the college campus should be decent and befitting the institution.
- Any student who is persistently insubordinate to teachers or staff, habitually irregular in attendance or inattentive to his work in the classes, repeatedly mischievous or obscene in words or act, indulges in movements which may lead to communal ill feelings or enmity will be liable for suspension, even expulsion from the College as per the decision of the Principal
- Students shall move silently when proceeding from one class to another so as not to disturb other classes.
- Student should attend classes, submit assignments, records etc. in time. Students coming late shall enter the class only with the permission of the teacher.
- Student absent from the class for more than three consecutive days should submit leave application at the Principal's office and copy to the respective department Heads. In case of illness medical certificate must be enclosed along with leave letter.
- Late comers will not get attendance for the period. No student shall leave the class before the class is dispersed by the teacher handling the class.
- Permission from the Principal/Shift In-charge is to be obtained by the student while leaving the college campus before the end of the classes.
- Students who happen to have no classes are not allowed to loiter in the veranda during class hours, instead they should remain quiet inside any free class rooms or in the library.
- Students are instructed not to represent the college at the university or any other place for any matter whatsoever, without the permission of the Principal.
- Students are prohibited from organizing or attending meeting in the College, distributing notices or collecting money for any purpose without the permission of the Principal.
- Instant agitation arising in the campus, disturbing the regular class work in the college is banned. Those involved in disturbing any class work in the campus are liable for severe punishment.
- No student shall communicate any information or write about matters dealing with the college administration to the press.
- The college properties should be handled with maximum care and everything possible should be done to preserve the sanctity of the building, furniture, library books and the premises.
- Based on the directions of the Higher Education CG, use of mobile phone and similar electronic gadgets inside the college campus is restricted. Mobile phones are to be switched off, when in the campus. If anyone is found violating this rule, the phone will be confiscated and strict action will be taken.
- Ragging in any form is strictly prohibited in the college according to the directions of the Government of India. Penalty measures to those found guilty of ragging will begin with immediate expulsion from the College followed by criminal procedures as per the law.
- Students have to appear for all the Unit Tests, Half Yearly Examination and Model Examination conducted by the college with sufficient preparation. Retest can be given to those students who represent the college in the cultural, sports and academics at different levels.
- Library rules shall be strictly followed. Students must work quietly while in the library or spend time in such a way as not to cause any interference with the work of others. Any student, who takes books from the college library without the knowledge of the librarian, exposes himself/herself to the gravest penalties. Tampering or loss of library books shall be compensated for by payment of thrice the amount of the price. Sub-lending of books is strictly forbidden.
- Students must park their vehicles only in the places specified for the same, and should not use the vehicles inside the campus beyond the parking areas.
- Under any circumstances, no student or staff or outsiders permitted to meet a faculty member while he is engaging classes or on invigilation work.
- Students are expected to see the College Notice Board every day.
- Students should always possess their identity cards (duly attested) with them and shall present it for inspection whenever demanded. In case of loss or misplacement new identity card will be issued after payment of Rs.150/-
- Canteen hours should be followed strictly.
- Students shall not be allowed to change sections allotted to them
- Students shall not bring any friends/ relatives etc to the college during regular classes, functions without prior permission of the Principal
- Smoking, alcohol consumption or use of any other narcotic substances is strictly forbidden in the campus.

DISCIPLINE AND ANTI-RAGGING COMMITTEE

The College takes discipline in its true spirit to equip its scholars to tune themselves to achieve their goals. Ragging is strictly prohibited in St Thomas College. Any student found indulging in any form of ragging, directly or indirectly, actively or passively, or being a part of conspiracy to promote ragging, within or outside the campus, would face strict disciplinary action by the college. St Thomas College is an educational institute and is committed to maintain learning environment that is free from harassment, exploitation, and discrimination. To achieve these objectives, the anti ragging committee has been constituted by the College comprising of discipline and anti-ragging committee and anti-ragging squad.

रैगिंग क्या है?

रैगिंग के अंतर्गत:

कोलाहलपूर्ण अनुचित व्यवहार करना, चिढ़ाना, भेद या अशुभ आचरण करना, उपद्रवी एवं अनुशासनहीन क्रिया-कलापों में संलग्न होना जिससे अन्य छात्र को गुस्सा, अनावश्यक परेशानी, शारीरिक अथवा मानसिक क्षति हो अथवा उसमें आशंका या भय बढ़ाने वाला हो, अथवा छात्रों से ऐसा कार्य करने के लिए, कहना जो छात्र/छात्रा सामान्यतया नहीं कर सकता/सकती और जिससे उसे शर्म या अपमान का अनुभव होता हो अथवा उसके जीवन के लिए, खतरा हो।

कर्नाटक शिक्षा अधिनियम, 1683 (कर्नाटक अधिनियम नं. 2,1664) अनुच्छेद 2(26) के अनुसार रैगिंग की परिभाषा इस प्रकार है:- किसी छात्र को मजाक में या अन्य किसी प्रकार से ऐसा कार्य करने के लिए कहना, प्रेरित करना या बाध्य करना, जो मानव - मर्यादा के खिलाफ हो या जो उसके व्यक्तित्व के विपरीत हो या जिससे वह हास्यास्पद हो जाए, या डरा-धमकाकर, गलत ढंग से रोक कर, गलत ढंग से बंद करके या उसे चोट पहुँचा कर या उस पर अनुचित दबाव डालकर या उसे इस प्रकार की धमकी, खललत अवरोध, गलत ढंग से बंदी बनाने, चोट या अनुचित दबाव का भय दिखाकर।

वैधानिक रैगिंग का स्वरूप :

रैगिंग निम्नांकित रूपों (सूची केवल निर्देशात्मक है- संपूर्ण नहीं) में पायी जाती है:

- सीनियर छात्रों को सर कहने के लिए, सामूहिक कवायद करने के लिए।
- सीनियर छात्रों के लिए, क्लास-नोट्स उतारने के लिए, अनेक सौंपे हुए कार्य करने के लिए, सीनियर छात्रों के लिए भृत्योचित कार्य करने के लिए।
- अश्लील प्रश्न पूछने या उनका उत्तर देने के लिए, नये छात्रों को अपने सीधेपन के विपरीत आघात पहुँचाने हेतु।
- अश्लील चित्रों को देखने के लिए, शराब, उबलती हुई चाय आदि के लिए बाध्य करना, कामुक संकेतार्थ वाले कार्य-समलैंगिक कार्य सहित, करने के लिए बाध्य करना।
- ऐसे कार्य करने के लिए बाध्य करना जिससे शारीरिक क्षति, मानसिक पीड़ा या मृत्यु तक हो सकती है।
- नंगा करना, चुंबन लेना आदि। अन्य अश्लीलताएँ करना।
- उपर्युक्त से यह विदित होता है कि प्रथम पांच को छोड़कर अधिकतर रैगिंग के विकृत रूपों से युक्त हैं।
