### Centre for Post Graduate Legal Studies, JGLS

All the LLM and PhD programmes at JGLS are offered under the aegis of the Centre for Post Graduate Legal Studies (CPGLS). The CPGLS at the Jindal Global Law School is established to provide students with quality teaching and learning opportunities thereby creating an intellectually stimulating academic environment with experienced and dedicated faculty

committed to provide an excellent and world-class education. The Centre has already commenced with a one-year LLM programme, which is the first programme of its kind in India, with specialisations being offered in Corporate and Financial Law and Policy, International Trade and Investment Law and Intellectual Property Rights and Technology Law, Taxation Law, Environmental Law, Energy & Climate Change and General LLM.

The faculty at CPGLS has a strong research orientation and LLM and Ph.D. students are expected to contribute to faculty and research center projects in the University. CPGLS promotes interdisciplinary studies, joint teaching and joint research programmes in partnership with other Schools in the University and with partner Universities of the O.P. Jindal Global University with which JGU established international collaborations and semester exchange programmes.

With respect to all the programmes under the aegis of CPGLS, the intensive curriculum provides a number of electives on contemporary topics in international and business oriented law streams. The courses and curriculum reflect the contemporary needs of a rapidly changing global legal profession. 

### About the Programme



## **LLM in Environmental Law, Energy & Climate Change**

### **A Collaboration between Centre for Environmental Law, WWF – India and O.P. Jindal Global University**

Environmental Law has emerged significantly in the post Stockholm period as a subject of structured and substantive dimensions having immense contemporary relevance. It has its roots and bearings in the ancient Indian traditions, wherein, the environmental ethics of the times was reflected through divine personification of the cardinal natural elements which are sun, air, fire, water and earth.

The journey through ages diluted the reverential aspect of environment and brought in gradual exploitation of nature that became more pervasive and systematic, especially, in the aftermath of the industrial revolution and the new nuclear age of the 21st Century. It had its grave portents for India too. The post -independence phase in India witnessed a gradual acknowledgement of the seminal importance of environment as an essential ingredient of 'Right to Life' and several apex court judgments were rendered highlighting this aspect.

With a more ecologically and socially conscious milieu; it is essential to minimize the adverse impacts of pollution and ecological degradation through proper environmental management and international cooperation. This can be done by not just raising awareness of environmental values but also strengthening the delivery capacity of environmental professionals so that they are well equipped to face the challenges in their stream of work. One of the ways to address a situation like this is to strengthen the human resource pool by creating efficient environmental lawyers. In this context, Centre for Environmental Law (CEL), WWF India in collaboration with Centre for Post Graduate Legal Studies (CPGLS), O.P. Jindal Global University (JGU) offers 'LLM in Environmental Law, Energy and Climate Change'.

This Course is useful for Law graduates who would like to develop specialist legal knowledge on national and global environmental issues. Similarly, law professionals working in the field of environment will be benefitted by a specialized Masters Programme in Law to enhance their knowledge in this field to help build their existing career from the unique LLM in Environmental Law, Energy and Climate Change.

#### **Programme Objectives**

The course will be first of its kind in the world with following objectives –

1. To study the symbiotic relationship between environment and climate change through the prism of the functioning of law and the relevant institutions with the objective of promoting sustainable development.
2. To study the role of law and legal institutions in the field of environment and climate change and its evolving relationship to public policy development and good governance.
3. To study the relationship between domestic and international law in the field of environment and climate change and how multilateral institutions and climate negotiations are affecting and impacting both domestic and international law and policy.
4. To study the role and impact of domestic and international adjudicatory mechanisms on environment and climate change with special reference to a critical examination and assessment of the functioning of the national environmental courts and tribunals.
5. To study the role and impact of dispute resolution mechanisms in the field of environment and climate change for examining issues relating to compensation, mitigation and other remedies for damages relating to the environment.
6. To study and analyse alternate energy solutions, available technical knowledge in the field of environment and climate change and how innovations in the field are best implemented.
7. To study how places and people are dealing with climate change, applicable environmental laws which provide viable solutions and to understand the principles and subject of climate adaptation.

#### **Academic Overview**

The One-Year LLM in Environmental Law, Energy and Climate Change consists of core/foundational and elective courses. The programme shall have minimum 28 credits with the following components:

Three Core/ Three Foundational mandatory courses (3 credits and 2 credits each)

Five optional courses of (2 credits/4 credits each) and Dissertation on a topic approved by the Dissertation Committee (3 Credits)

The Electives will cover:

- International Environmental Laws – Interface between Environmental Laws, Energy Laws and Climate Change: International Conventions, Global Developments, Case Study and Solution Based Approaches.
- National Environmental Laws – Interface between Environmental Law, Energy Laws and Climate Change: National Laws and Policies, Institutional Frameworks Resulting in Effective Implementation.
- Energy Laws and Policies – Sectoral Coverage, Technical Case Studies and Solution Based Approach.
- Climate Change Governance - Financing in Climate Sector, Technological Innovations, Alternate Energy Regimes, Urban Green Living.
- Renewable Energy Development in India: Status, Projections and Prospects
- Climate Adaptation: Introduction and Current Global and National Perspectives explained through Case Studies and on Ground Scenarios.
- Field Trip – Mandatory Study Tour to a conservation site which demonstrates implementation of laws and policies, best practices & sustainable living.

#### **LLM in Environmental Law, Energy & Climate Change**

Law graduates who would like to develop specialist legal knowledge to tackle global challenges like climate change may benefit from a unique LLM which covers subjects of Environmental Law, Energy and Climate Change. Similarly, law professionals or anyone working in the field of environment will be benefitted by a specialized Masters Programme in Law to enhance their knowledge in this field to help build their existing career.

#### **Curriculum Development**

A panel of experts from across sectors will be invited to review the curriculum developed by WWF- India and JGU. A programme Advisory Committee for LLM in Environmental Law, Energy & Climate Change.

JGU was ranked among the top 450 universities in Asia on the QS Asia University Rankings 2019, and became the youngest Indian University to feature in the QS BRICS Rankings 2019. JGU was one of only two private universities to be ranked out of the top 75 Indian universities on these rankings.

JGU was ranked in the 251-300 rank bracket of the QS University Rankings: BRICS 2018 Edition. JGU is ranked in the top 300 universities out of 9,000 universities in the BRICS region (covering five countries – Brazil, Russia, India, China, South Africa), placing it in the top 2.8% of the universities in the BRICS region. JGU is also the first and only private university in Haryana to have been ranked in an international ranking.

## Scholarships

### O.P. Jindal Outstanding Merit Scholarships

The top five LSAT—India test scorers who enroll in the three year LL.B. programme, five year B.A./B.B.A. LL.B. (Hons.) programme and a one year LLM programme will be awarded the O.P. Jindal Outstanding Merit Scholarship of Rs. 1 lakh per year. This will be based solely on their performance in the LSAT—India admission test.

### Naveen Jindal Young Global Scholarships

The aim of the scholarship is to nurture, encourage and support young global leaders. One student from the five year B.A./B.B.A. LL.B. (Hons.) programme, One student from the three year LL.B. and another student from the one year LLM programme will be awarded this scholarship on the basis of an independent selection process. An award of one year programme fee will be given to the student of B.A./B.B.A. LL.B. (Hons.) and LL.B programme and for LLM 50% of the programme fee will be awarded to the selected student of LLM programme.

### Shallu Jindal Outstanding Women Scholarships

The aim of the scholarship is to nurture, encourage and support outstanding women to enter the field of law. Two students from the three year LL.B. programme, two students from the five year B.A./B.B.A. LL.B. (Hons.) and two students from the one year LLM programme will be awarded this scholarship on the basis of an independent selection process. An award of 50% of one year programme fee will be given to each student.

Studentships ranging from 10% to 75% of tuition fees are awarded on merit-cum-means basis to a substantial number of selected students as per university rules.

Students who qualify under Haryana domicile category may be eligible for full or partial fee concession.

## Education Loans

JGU has established tie-ups with HDFC Bank, Credila, Dena Bank and ICICI Bank to facilitate education loans to students who are admitted at JGU.

## International Student Exchange and Study Abroad Programmes

Students have been nominated to pursue postgraduate study abroad programmes at Osgoode Hall Law School, York University, Canada and the Maurer School of Law, Indiana University, Bloomington, USA, East China University of Law and Political Science, Shanghai, China. Students have pursued a second LLM programme at the Zhejiang University School of Law, China.

## Jindal Brunel Double Degree LLM Programme

To facilitate the LLM students of CPGLS, JGLS to earn a world-class second LLM from Brunel University, U.K., an historic MOU has been signed between both the Universities. This Dual LLM offered by JGLS and Brunel enables law graduates to earn both an Indian LLM from JGLS and an UK LLM from Brunel University in a much lesser time and cost. A joint supervision of LLM Dissertation at JGU by the JGLS Faculty Member with Brunel Faculty, is a landmark clause which helps LLM students to write and submit one dissertation at JGLS which will satisfy the requirements of both the programmes.

After spending one year at JGLS in its one year residential LLM programme, a student may choose to shift to Brunel, UK and earn his second LLM by spending one year at Brunel University London to earn:

- LLM Law
- LLM International Commercial Law
- LLM International Financial Regulation and Corporate Law
- LLM International Human Rights
- LLM International Intellectual Property

1. The students of Dual LLM programme must submit a valid IELTS score of 6.5 or above with a minimum 6.0 in each of its element and above.
2. 15% of Tuition Fee Concession shall be awarded to every LLM student of CPGLS who chooses to pursue the Dual LLM at Brunel University.
