

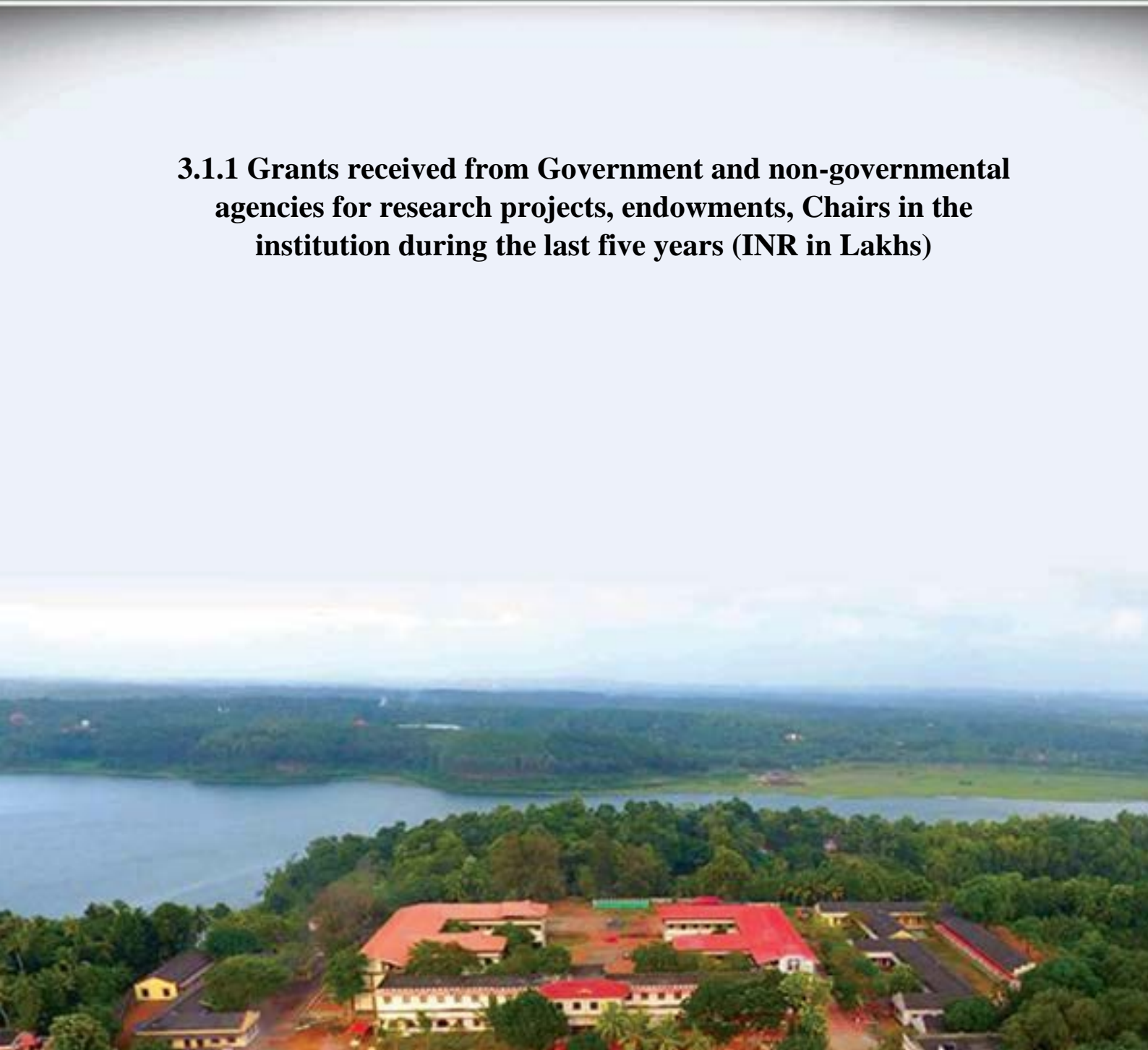

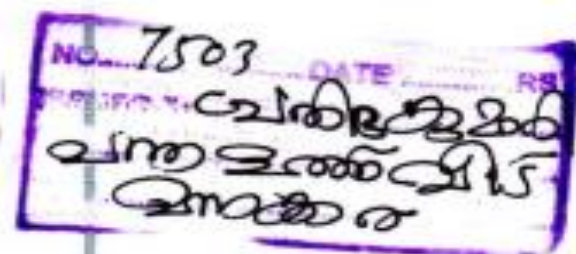

5. I agree that the grant sanctioned by the Council to the author for this specific Project will be Rs. 3,00,000/- (Rupees three lakhs only). The entire sum provided will be utilized exclusively for the execution and completion of this Project.

6. I agree that the grant may be disbursed as follows:

- Payment of Rs. 1 lakh at the signing of the undertaking.
- Payment of Rs. 1 lakh at the end of twelve months, once ICWA, after its internal scrutiny of the draft manuscript is satisfied that adequate progress towards research and writing has taken place.
- Last and final payment of Rs. 1 lakh after the book is published.

7. If the case requires; the Council will set aside a sum of up to Rs. 4 lakh to enable the author to undertake field trips. The amount will be reimbursed on the basis of actual and after production of required receipts/vouchers. Council may consider providing advance amount in part or in full to enable the author to undertake field trips, based on justification received from the author to this end, as an exception.

Adjustment of Advance: The advance will be recovered by adjustment from the TA bill submitted with original bill, vouchers, boarding passes, tickets etc. within 15 days after submission of the bills in the Council. The claim will have to be preferred as per existing TA rules of Government of India.

The book project will not exceed Rs. 7 lakhs.

- In this regard, I agree to submit a detailed proposal for the field visits along with the objectives to be achieved, estimated expenditure to be incurred and justification for request for advance if any.

8. I agree to refund the entire grant as well as reimbursement of field trip expenditure, along with interest as per existing provisions of GoI General Financial Rules (GFR) at the time of signing of contract/undertaking, sanctioned to me by the Council under clause 5 and 7 if:

- I fail to complete the Project within the stipulated period; or
- I contravene any of the terms of this Undertaking;
- Except** under any unforeseen or extraordinary circumstances, which is brought to the notice of the Council in writing and accepted by the Council. 



**ORDER**

Government of Kerala have formed the Kerala Development and Strategic Council (K-DISC) to give a thrust to innovation in the State. The mandate of K-DISC is to identify and nurture a critical mass of innovations in the State and provide appropriate institutional linkages to the selected innovations. K-DISC aims at bringing out path-breaking strategic plans that reflect new directions in technology, product and process innovations, social shaping of technology and creating a healthy and conducive ecosystem for fostering innovations in the State.

As per the Government Orders read as 1 to 3 above, K-DISC constituted its district arms, the District Innovation Councils (DInCs) with District Panchayat Presidents as Chairpersons and District Collectors as Conveners and reconstituted them with a view to enable implementation of district level activities. As per the Government Order read as 4 above, sanction was accorded for the One District One Idea (ODOI) – MSME Innovation Clusters' programme of K-DISC. The guiding principle towards the innovation cluster approach is that Micro, Small and Medium Scale Enterprises (MSME) can play a key role in local economic growth and equitable development. A detailed description of the ODOI programme and the role of District Innovation Councils is appended as Annexure 1.

The ODOI programme will make use of the Triple Helix Model, aiming to strengthen the Academic-Industry-Government interface for implementation. This will be constituted with identified institutions and business schools, clusters finalised by the DInCs, and KDISC/ Digital University (DU). A note on the proposed model is provided as Annexure 2.





The initial step of the ODOI- MSME Innovation cluster's programme is to shortlist the clusters in each district. One hundred and fifteen (115) innovation clusters have been identified so far comprising of MSME clusters, Handicraft clusters, Handloom/ Power-loom clusters, Craft clusters and Traditional/ Service sector clusters, Farmers' Producer Organisations (FPOs), clusters that can be projected as the identity of the district, and companies that use modern technology. The list of clusters identified district-wise is furnished as Annexure 3.

As part of mobilising the academic partners, K-DISC had invited EOIs from leading academic institutions for their association with the ODOI program. A total of one hundred and one EOIs were received. An expert committee was constituted for overseeing the process. Based on the evaluation of the criteria published in EOI, sixty-three (63) institutions were shortlisted out of the one hundred one (101) EOIs received. After careful examination of the EOI submissions, institutions were indexed based on the criteria as per EOI. Among the selected institutions, 11 belong to the Class A within the district category, of which 10 is also eligible for outside district. Similarly, 52 belong to class B within district category. The list of selected institutions is given as Annexure 4.

The expert committee had scrutinised the applications on 25<sup>th</sup> March 2021 as per reference read as paper and recommended rates of contracts and reimbursements after considering the scope of work and deliverables for the said work. Students, faculty, and external experts shall be engaged to carry out the necessary work. The scope of work and deliverables have been attached as Annexure 5.

The maximum rates admissible for students' stipend and TA, and expenses for faculty and experts have been decided as follows.

The estimated duration of work and the breakup of the expenses allotted have been provided as Annexure 6.

The payment terms for the institutions shall be as follows.

1. 20% release on completion of training and allocation of clusters by DInC.
2. 50% release on submission of the draft report.
3. 30% release on submission of final report and audited statement.

The institutions should complete the stipulated work adhering to the estimates provided. No further payments shall be made for the work/ time spent beyond the estimated amount of days/ work. Institutions are directed to furnish a statement audited by a chartered accountant after completion of the project.

The shortlisted institutions, in agreement with the terms of engagement and deliverables, are directed to sign the MoU (as given in the EOI) with K-DISC in 10 days after issuing the order. Subsequently, cluster allocation by DInCs will be based on evaluation of baseline data, value-

### ORDER

Subject: Financial assistance (1<sup>st</sup> installment) to the KSMDJ College, Sasthamcotta, Kollam, Kerala-690521 under FIST Program.

Sanction of the President is hereby accorded to the approval of the aforesaid project at a total cost of Rs.69,40,000/- (Sixty nine lakh forty thousand only) for 5 years. The detailed breakup of the grant for General as well as Capital Components are given below.

To strengthen teaching facilities in the College.

The sanction of the President is also accorded to the release of Rs.52,50,000/- (Rupees Fifty two lakh and fifty thousand only) to the Principal, KSMDJ College, Sasthamcotta, Kollam, Kerala-690521 under FIST Program as a 1<sup>st</sup> installment of the grant in 2019-2020 under 'creation of capital assets' head for the maximum cost of the aforesaid Equipment including (9.4%) Custom Duty & other duties under the 'Equipment'. The break-up of the 1<sup>st</sup> installment grant released now would be Equipment: Rs. 52.0 lakh for procurement of the equipments mentioned above [Equipments of Foreign Origin to be acquired on FE Terms only and should not include charges for any comprehensive Maintenance and training personnel from the vendors during procurement process] and for IF- Rs 0.50 (Books)

4. The Department/Institute will appropriately limit the expenditure within the sanctioned amount in case of any expected excess expenditure. The Department is requested to utilize the released funds in first one year from the date of sanction order.

5. This sanction is subject to the condition that the grantee organisation will furnish to the Department of Science & Technology, financial year wise Utilization Certificate (UC) in the proforma prescribed as per GFR 2017 and audited statement of expenditure (SE) along with up to date progress report at the end of each financial year duly reflecting the interest earned / accrued on the grants received under the project. This is also subject to the condition of submission of the final statement of expenditure, utilization certificate and project completion report within one year from the scheduled date of completion of the project.



6. The grantee organisation will have to enter & upload the Utilization Certificate in the PFMS portal beside sending it in physical form to this Division with UC id generated in PFMS Portal. The subsequent/final instalment will be released only after confirmation of the acceptance of the UC by the Division and entry of previous Utilization Certificate in the PFMS.
7. If the grant has been released under Capital head/General through separate sanction order(s) under the same project for purchase of equipment, separate SE/UC has to be furnished for the released Capital head/General grant.
8. There is no pending SE/UC on this Project as per details in the PFMS also. This is the first release of this project under FIST Program, which has been initiated, in this financial year so no previous UC is attached with this sanction order.
9. The grant-in-aid being released is subject to the condition that:
  - (a) a transparent procurement procedure in line with the provisions of General Financial Rules 2017 will be followed by the University/Institute under the appropriate rules of the grantee organisation while procuring capital assets sanctioned for the above mentioned project and a certificate to this effect will be submitted by the University/Institute immediately on receipt of the grant, and
  - (b) while submitting Utilization Certificate/Statement of Expenditure, the University/Institute has to ensure submission of supporting documentary evidences with regard to the purchase of equipment/capital assets as per the provisions of GFR 2017. Subsequent release of grants under the project shall be considered only on receipt of the said documents.
  - (c) Grantee Institute may furnish copy of invoice in respect of equipments worth Rs. 5.0 L and above along with customs clearance certification (in case of imported equipments) after procurement of the equipments.
  - (d) Servers, Desktops, Workstations, Printers etc. may be procured through GeM (Government E-Market) platform.
  - (e) Grantee Institute will furnish copy of bills showing expenditure incurred on maintenance of the existing equipments/NW items and the new Equipments/NW items after warranty period of the new equipments/NW items are over.
10. "In terms of Rule 230(8) of GFR 2017, the grantee organization will maintain separate audited account for the project and the entire amount of grant will be kept in an interest bearing bank account. For Grants released during F.Y. 2017-18 and onwards, all interests and other earnings, generated against released Grant shall be remitted to Consolidated Fund of India".
11. DST reserves sole rights on the assets created out of grants. Assets acquired wholly or substantially out of government grants (except those declared as obsolete and unserviceable or condemned in accordance with the procedure laid down in GFR 2017), shall not be disposed of without obtaining the prior approval of DST.
12. The account of the grantee organisation shall be open to inspection by the sanctioning authority and audit (both by C&AG of India and Internal Audit by the Principal Accounts Office of the DST), whenever the organisation is called upon to do so, as laid down under Rule 236(1) of General Financial Rules 2017.
13. Due acknowledgement of technical support / financial assistance resulting from this project grant should mandatorily be highlighted by the grantee organisation in bold letters in all publications / media releases as well as in the opening paragraphs of their Annual Reports during and after the completion of the project.




