Honoured Sir,

The brief facts of the case are that occurred prior to 08.05.2026 at Jyothinagar, Karimnagar and reported on 08.05.2026 at 17:00 hrs by the complainant Bandi Bageerath s/o Sanjay kumar r/o Jyothinagar, Karimnagar, in which he stated that, the A-1 [REDACTED] got acquaintance with the complainant on the name of friendship, further she invited him to her family functions and group gatherings, believing them to be trustworthy, he accompanied with them and all they visits holy places. Subsequently, sai [REDACTED] and her parents intimidating him to marry her, but he refused said proposal. Upon which she along with her parents A-2 and A-3 and others demanded money from him, and also threatened that if he fails to provide such amounts they will file false criminal complaints against him including the allegations of harassment and physical relationship. Due to their fear he gave an amount of Rs 50,000/- to the father of A-1. But they did not satisfy and further demanded him to give Rs 5-crores otherwise the mother of A-1 would commit suicide.

Hence, the FIR.

4. Any other accomplices involved The brief facts are as follows:

I came into contact with Ms [REDACTED] through a common friend. As we were all a group of friends and the parents representing themselves as respectable persons and with the active involvement of her parents, they developed friendly relations with me and my group of friends.

Under the guise of friendship and social association, they invited me and my friends to family functions and group gatherings and spiritual locations believing them to be trustworthy and being part of a larger friend circle, I travelled with them and other friends to Vijayawada Temple, Arunachalam Temple, and Tirumala Temple as a part of the friends group.

After a period of time subsequently, their behaviour changed, and the parents called me and began pressurizing and intimidating me to marry Ms [REDACTED] their daughter. Upon my refusal, they threatened to file false criminal complaints against me, including allegations of harassment and physical relationship. They have also demanded substantial sums of money from me and in fear I have given his father a sum of Rs. 50000/- (Rupees Fifty thousand only) and requested him leave me alone post that the parents have been continuously subjecting me to mental harassment and coercion by stating that Smt [REDACTED] (his wife) would commit suicide if I didn't pay them a sum of Rs. 5.00 Crores (Rupees Five Crores).

The actions of the above-named persons clearly disclose cognizable offences, including criminal intimidation, extortion, criminal conspiracy, and harassment.

It is further submitted that a few of my friends had a similar issue with these people and had earlier lodged a complaint against Ms. [REDACTED] at Nirmal Police Station on 21 April 2026, and it is reported that an FIR has been registered in that regard.

In view of the above, I request you to:

1. Register an FIR against [REDACTED] and their accomplices.
2. Conduct a fair and thorough investigation into the acts of intimidation and attempted extortion.
3. Provide me necessary protection from further harassment or false implication.


I am ready to cooperate with the investigation and provide any further details or evidence as required.

Kindly treat this matter as urgent.
