SPACE AND FACILITIES:

- 1. Shell Scheme Stalls: Minimum area 9 sq. Mtr. Package of facilities for shell scheme stalls include back and side partitions with modern prefabricated system, carpet, facia in English with stall numbers written in uniform style, three spot lights, one 15 / 5 amp socket per stall, one dustbin, one laminated table and two chairs per stall of 9 sq. Mtr. Area. All other setup will have to be done by the exhibitor. Any specific requirements should be taken care of by exhibitor themselves. The extra electric consumption shall be billed separately which should be informed in advance latest by 15th Nov. 2018.
- 2. Open Space: Minimum Booking 36 sq. Mtr. Package of facilities for Open space includes General Carpeted Setup along with Basic Lights and one 15 / 5 amp socket per stall and two chairs per stall. All other setup will have to be done by the exhibitor. Any specific requirements should be taken care of by exhibitor themselves. The extra electric consumption shall be billed separately which should be informed in advance latest by 15th Nov. 2018.

Allocation of Space: The Expo is meant for Maheshwari exhibitors only. The basis of Allotment will be neutrality, aesthetic appeal, conformity with floor plan layout and product categories. Allocation will be subject to receipt of full payment in advance. Allocation of stall location will be communicated in writing by the organizers.

Availability of Space for preparation and readiness thereafter: The stalls will be setup and ready to move in on 1st Jan, 2019 by MGE'19 team and all the stalls are expected to be ready by the exhibitor by 2rd Jan, 2019 night in any case. As the ground conditions are sandy and multiple layers of carpeting is planned, all vehicles carrying goods shall be restricted at entry point after January 2, 2019 and goods/material may be carried from entry point only. Inaugural of the Maheshwari Global Expo 2019 shall be on 4th Jan, 2019.

Alteration of Space Allotted: The organizers reserve the right, to make such alterations in the ground plan of the Exhibition, as in their opinion may be necessary and to alter the shape, size of the position of the space allotted to the Exhibitor at any time. However, no alteration to the space allotted will be made in such way as to impose on the Exhibitor any greater liability for rental than that undertaken in the form.

Cancellation & Reduction of Space: In case of cancellation or withdrawal from participation of the stall by any Exhibitor, the paid amount shall be forfeited. However reduction of space area (If more than 1 stall booked) may be allowed by the organizers at their discretion and without assigning any reason elect whether or not to accept any reduction request.

Rights of Organizers: The organizers reserve the following rights:

- 1. To reject any application for space without assigning any reason.
- 2. To amend any of the above conditions for participation and/or imposition of additional Rules and Regulations for participants from time to time, this shall be binding on all participants without any obligation on the organizer.
- 3. To change the stall location or to make certain changes, alterations, curtailments in the final allotments of stall areas with respect to that originally booked by the exhibitor.
- 4. To use names, logos, etc. of exhibitor as and when required including and not limited to news, print media, social media, website, app, etc.

Insurance Coverage & Organizers Indemnity: The onus to obtain insurance coverage against all risks arising from transport of exhibits and their display during the Exhibition, particularly against theft, etc. shall be on the exhibitors only. The Organizers shall not be liable for personal injuries and material damage including theft of any exhibit / good or damage due to any unforeseen circumstances and act of god. There will be an overall general insurance of the exhibition of approximate amount, however, exhibitors are advised to insure their products as per their own requirement.

General Rules: In addition to the above the exhibitor shall abide by the general rules of MGE'19. For safety and maintenance as well as for aesthetic appeal. No hoarding banners etc. will be allowed outside the dome and/or on the roads in the vicinity. Exhibitors must take extra care to ensure that there is no damage to the material provided by MGE'19 at the venue and if it takes place, same shall be compensated to the extent of its value.

Final Decision: In case of any dispute in interpretation of conditions for participation, or between exhibitors, the decision of the Organizers namely MGE'19, shall be final and binding on all parties.

Force Majeure: Under the condition of the force majeure which also include strike, lock out, closures, riots, heavy rains, act of god the organizer reserves the right to alter the opening dates and duration or even cancel the entire expo. In case of change in dates and duration of MGE 2019 the contractual obligations between the Exhibitors and the Organizer remain unaffected. In case of cancellation of the Expo the stall charges will be refund to the Exhibitors after deducting the cost already incurred by the Organizer.

Arbitration: All disputes arising in connection with this agreement shall be finally settled by a sole Arbitrator to be appointed by the organizer under the provisions of Indian Arbitration and conciliation Act 1996. The place of arbitration shall be Jodhpur (Rajasthan) only.

1Jurisdiction: Only the courts in Jodhpur shall have Jurisdiction.
