5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM** on **02 Oct. 2026** at the office of **Madhesh Institute of Health Sciences, Janakpurdham**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NPR **4,50,000.00**, which shall be valid for 30 days beyond the validity period of the bid (i.e **120 days**)
