Re-Constitution of the Students Grievance Redressal Committee (SGRC)

In pursuance to the UGC (Redressal of grievances of Students) Regulations, 2023, the Student Grievance Redressal Committee of Jain (Deemed-to-be University) is hereby Re-Constituted as under **w.e.f. 03/05/2023**.

All the students enrolled at JAIN (Deemed-to-be University) have the right to appeal any academic matter in which they feel that they have been treated unfairly. **Examples of student problems:** Disputes over Grades, Course Requirements, Faculty or Staff Conduct, Fines and Administrative Policies and Procedures.

If any problem arises and is not resolved formally, students may file a grievance with the Nodal Officer or Chairperson of SGRC as stipulated in University Grants Commission (Redressal of Grievances of Students) Regulations, 2023. Any type of student complaint or problem as occurred in the respective campus premises and hostel may be presented to the SGRC for official review. The hearing body follows a set of formal procedures as per UGC Guidelines.
