Terms and Conditions

- 1. Successful Bidder has to sign a Rate contract with RHFL to fix a price for 1 year for the Audit, Supply, Installation and Maintenance of UPS, Inverter and Batteries to all RHFL branches, within 15 days.
- 2. Awarded vendor has to visit all our RHFL branches and submit a detailed report consisting of below, upon verification;
 - 1. Electricity load report,
 - 2. Sufficient UPS, Inverter and batteries are available or not,
 - 3. Status of existing UPS, Inverter and Batteries,
 - 4. In AMC period any fault in UPS or inverter then the same has to be brought to RHFL's notice with quotation.
 - 5. Electrical wiring needs to be done for changeover of power supply
- 3. Based on the branch-wise report RHFL will analyze and release P.O (Purchase Order) to the successful bidder
- 4. For Auditing RHFL Branches, No travel expenses will be reimbursed from RHFL, the Vendor has to arrange on their own.
- 5. Bidder shall raise an invoice for auditing fees for RHFL offices.
- 6. The above Exercise has to be completed within 5 months from the date of signing rate contract with RHFL.
- 7. After releasing the P.O (Purchase order) within 10 working days' the bidder has to complete and submit the report to RHFL along with the payment invoice.
- 8. After change of new UPS based on the recommendation then till warranty period Bidder has to support for any claims
- 9. In AMC (Annual Maintenance Contract) period calls have to be attended within 24 to 36 Hrs in person and Replacement of UPS has to be done within 3 days.

- 10. In AMC period successful Bidder has to visit all the branches at least two times in a year. The visit report has to be submitted along with RHFL Branch Manager Seal and signature with date.
- 11. RHFL takes 10 working days to release the payment from the date of the submitting the completion report.
- 12. The bidder shall dismantle and take away old UPS, Inverter and Batteries from the premises under buy-back. A consolidated rate may be quoted in the price bid. The amount quoted under buy-back will be deducted from the amount quoted for providing new UPS, Inverter and Batteries, the final amount will be considered for payment.
- 13. The service provider shall comply with the compliance requirements outlined in the RHFL Information Security Policy, Cyber security Policy, and other applicable policies and procedures.
- 14. Tenders to be submitted in a sealed cover super-scribing the "Audit, Supply, Installation, and Maintenance of UPS, Inverter and Batteries at RHFL PAN India Branches.
