#### INTIMATION FOR ADDITION IN BANK ACCOUNT DETAILS FOR STAMP DUTY

DPs are advised to refer to Communiqué no. CDSL/OPS/DP/POLCY/2020/8 dated January 3, 2020, intimating various modes of advance stamp duty payments that can be used to make payment to CDSL.

CDSL has now introduced stamp duty collection system using virtual account number through HDFC Bank in addition to ICICI Bank. Now, DPs / Beneficiary Owners (BOs) can make advance stamp duty payments in any of the bank accounts using virtual account number allotted to the payor by CDSL.

Following are the virtual account details for payment of advance Stamp Duty:

#### Payment Instructions for DP and Beneficiary Owner:

- 1. The stamp duty amount has to be paid by DP/BO in the designated stamp duty account only and the advances/ credit balances lying in regular operational account cannot be used for discharge of stamp duty payments.
- 2. The Stamp Duty payment can be made only through RTGS/ NEFT/IMPS using VAN. (Cheque, Demand draft and Pay orders will not be accepted for stamp duty account).
- 3. The DPs/BOs are further informed that the above VAN shall be required to be added as Beneficiary in their respective internet banking portal to make payments.
- 4. If DP/BO does not have internet banking facility for their account, they have to give physical request to respective bank for RTGS/ NEFT/IMPS quoting VAN as mentioned above. The said process is to be checked with respective banks by the DPs.
- 5. DPs/BOs are informed that in case of VAN mismatch, the amount remitted to CDSL will be auto reversed by bank.

DPs/BOs can download the receipt copy for the advance stamp duty amount paid from the link https://bills.cdsl.co.in/#forward using their login credentials.

All DPs/BOs are requested to take note of the above addition in bank details and initiate suitable backoffice changes, if any and inform their clients accordingly.
